- 7. Identify and collaborate with parent and education leaders, SEPAGs, parent and community groups, networks and/or formal organizations (FSC, CCYCs, FSO, RFSPC, PTAs/PTOs/HSAs, etc.) currently serving, supporting, or interested in supporting families with children with special education needs.
- 8. Outreach to identified groups/networks/organizations to determine what resources or information may be needed to sustain their development.
- 9. Coordinate opportunities for parents, parent group leaders and professionals to network, share resources, engage in mutual problem-solving to increase parent leadership capacity and help build family/school partnerships.
- 10. Collect and maintain all required data for reporting and program implementation.
- 11. Network with families, educators, and service providers as well as attend conferences and trainings in their counties, regions, and throughout the state regarding family-centered principles and practices.
- 12. Contribute content related to activities and relevant topics to the Project's and organization's publications, presentations, social media, and website.
- 13. Attend necessary and mandatory professional development activities.
